

This is an historic footpath and part of the heritage of Ratley, a village built on a hill with lots of steep footpaths and cut throughs. This particular route was previously a road, inking up to Town Hill and French's Lane and can be seen on the 1881 map which is printed in "Ratley – The Story of a Warwickshire Parish" which details the Reverend Childs visiting route to the families of the parish. Over a century ago it linked the farm yard at Ratley Manor (now Manor Farm) to the top of the village. Throughout the past 2 centuries it has been an important route linking facilities such as the village stores, post office and working man's club/reading room to houses at the top. Those living at the bottom of the village would have used it as the quickest route up to the chapel, village school and these days it is a short cut to the village hall. This is shown in the photograph included with the application taking in the early 1930's, which shows 2 people walking on the path next to what was at the time the village store. The milk churn and the cart used to transport the churns up and down the path can be seen at the foot of the path.

This path, along with 2 other routes, links up the 3 village green areas that are registered to Ratley District Council in a triangular route – see map VG140.

The path is clearly marked by handrails that have been there for some time and are maintained by the Parish Council (the land owners). I am unsure when they were 1<sup>st</sup> installed but they have been there for at least 50 years as they are visible in the aerial photograph taken in 1964 which is included with this application. It is also of note, as advised by older residents in the village, that the Council Council actually placed down the existing concrete/stone surface that covers most the path.

This path has been used for centuries and continues to be used by villagers and visitors to Ratley. It is the shortest route from the village hall down to the bottom corner of the village and entrance to the nature reserve. Because of it's convenient route from the village hall it has been used by a large number of children (in particular Ratley Toddler Group and Ratley Youth Club) over the years during village events such as Easter Egg Hunts, Village picnics, Treasure Hunt, Trick or Treating etc.

The path continues to be used regularly and is a presumed right of way, however it is not recorded on the definitive map held by the county council. In recent years, the owners of The Old Post Office, the property adjacent to the path, have repeatedly applied for planning permission to divert the route of the path, making it longer and less convenient, in order to build a garage in the area where the path is currently routed. The first planning application was withdrawn and the current application is pending a decision. However, it is noted that the consultation with the rights of way team gave no objection to changing/removing the path as it is not a recorded right of way.

I have spoken to a number of residents about the path and they all feel strongly that they wish to keep the footpath in it's current route and location. I am therefore requesting that the path is recorded on the Definitive Map in order to protect it as a walking route for current and future generations of Ratley residents.
