Statement of Evidence

- 1) This route has its origin as a medieval accommodation road from Warwick Road east in to the fields and was known as "Vials Lane" in an Extent of 1591 (County Record Office ref. CR576/1).
- 2) The west end of this route is shown as a lane on the estate map of 1692 (County Record Office ref. CR143/1).
- 3) The deposited railway plan of 1841 for the Warwick and Leamington Branch Railway (County Record Office ref. QS111/129/1+4) shows and lists the route as item 62: "occupation road", owned by the Surveyor of Highways (i.e. as a public highway).
- 4) The first edition one inch Ordnance Survey map of 1834 (with the railway added) shows the route as crossing the railway.
- 5) The Tithe Apportionment Map of 1849 (County Record Office ref. CR569/139) shows, and labels part of the route as "awarded road", with no number and no tithe payable. (This suggests it was unproductive waste and considered to be a public highway.)
- 6) The Board of Health map of c. 1877 shows the route as a bridge over the railway.
- 7) The route is shown on all large scale Ordnance Survey maps.
- 8) The part of the route to the east of the railway is recorded on the Definitive Map as footpath K26.
- 9) The section to the west of the railway was rebuilt as Clarkes Avenue.
- 10) The route is shown on the plan of the list of streets kept by the District Council as agents for the Highway Authority as being maintainable at public expense.
- 11) The claimed route is the section in the former exclude area between the west end of K26 across the railway to Clarkes Avenue, has a tarmac surface, cycle barrier, and 'no cycling' notices. It is well used by the public.
