Statement of Evidence

1) This route was created by the Kenilworth Inclosure Award 1756 (County Record Office ref. QS75/63) where the 10th public road is described as going from Wood Mill [now the site of Forge Road] through the allotment to the poor [now called Kenilworth Common] to the private way set out between the plots to John Hayward and William Bettey, the road being 50 feet broad. (The 'private way' was the second such road and went from the Turnpike Road to the Poors Plot. It is now the north end of Common Lane.)

2) The road is shown on the 1834 first edition of the Ordnance Survey map (which has the railways superimposed) and on all large scale Ordnance Survey maps

3) The route is a well used track across the common and has the remains of a stoned surface, in parts.
