Statement of Evidence

- 1) K14 (bridleway) and K13 (footpath) are only recorded from the boundary of the former excluded area and there is only one route shown for the missing sections on all the maps.
- 2) The Estate map of 1692 (County Record Office ref. CR143/1) shows the track from Castle Road through The Brays (i.e. the route of K14)
- 3) The first edition of the Ordnance Survey one inch map, 1834, shows this track.
- 4) The Board of Health drainage map of c.1877 shows this route through The Brays and labels it as "occupation road"
- 5) The sale particulars of 1917, for the castle estate, confirms this track was a right of way.
- 6) Both this track, and the link to path K13, are shown on all large scale Ordnance Survey maps
- 7) This track is surfaced and well used by the public, with the footpath passing over the grass to a stile.
