I hereby apply for an Order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the County of Warwick by **Adding** the following route as a -

Making your Application

Note on this application form all the documents you are using as evidence, attach copies if possible and any photographs.

Please ask anyone who wishes to give evidence that they have used the route, to fill in a "Witness Statement" Form G. Collect the completed forms and return them with your application.

- ◆ Evidence - documents, plans, photographs (if applicable)

Evidence

All references are to documents held by the County Record Office.

The evidence is for the whole route of this path, not just the section being claimed. The relevant sections are: (a) A-B = the claim and is the vehicular track to the west of the Pottertons former factory. (b) B-C = the section through the Percy Estate. (c) C-D = the existing public footpath WB1.

1) The path was created by the Warwick (St Nicholas) Inclosure Award 1773 (QS75/123) being the 2nd footway in Coton Field. It was described as going from Edmundscote Bridge, through allotments to five owners, to the road to Coventry. The path was to be 4 ft wide but the south-east half was subject to (private) vehicular rights.

2) The route, in whole or part, is shown on various estate, and other, maps as well as on the 1887 and 1925 Ordnance Survey maps. These include:-

(a) Castle Estate Map 1836 (CR1886/M40)

(b) Warwick, Worcester and Rugby Railway 1845 deposited plans (QS111/187) as "Footpath from Portobello Tavern to Guys Cliffe". Owner: Surveyor of Highways

(c) Leamington, Warwick and Stratford on Avon Railway 1852 deposited plans (QS111/212) labels "footpath", owner: Surveyor of Highways [Section A-B]

(d) Deed of conveyance, with plan, of 1866 (CR1886/Box 453/20) shows path along east edge of site [part Section A-B]

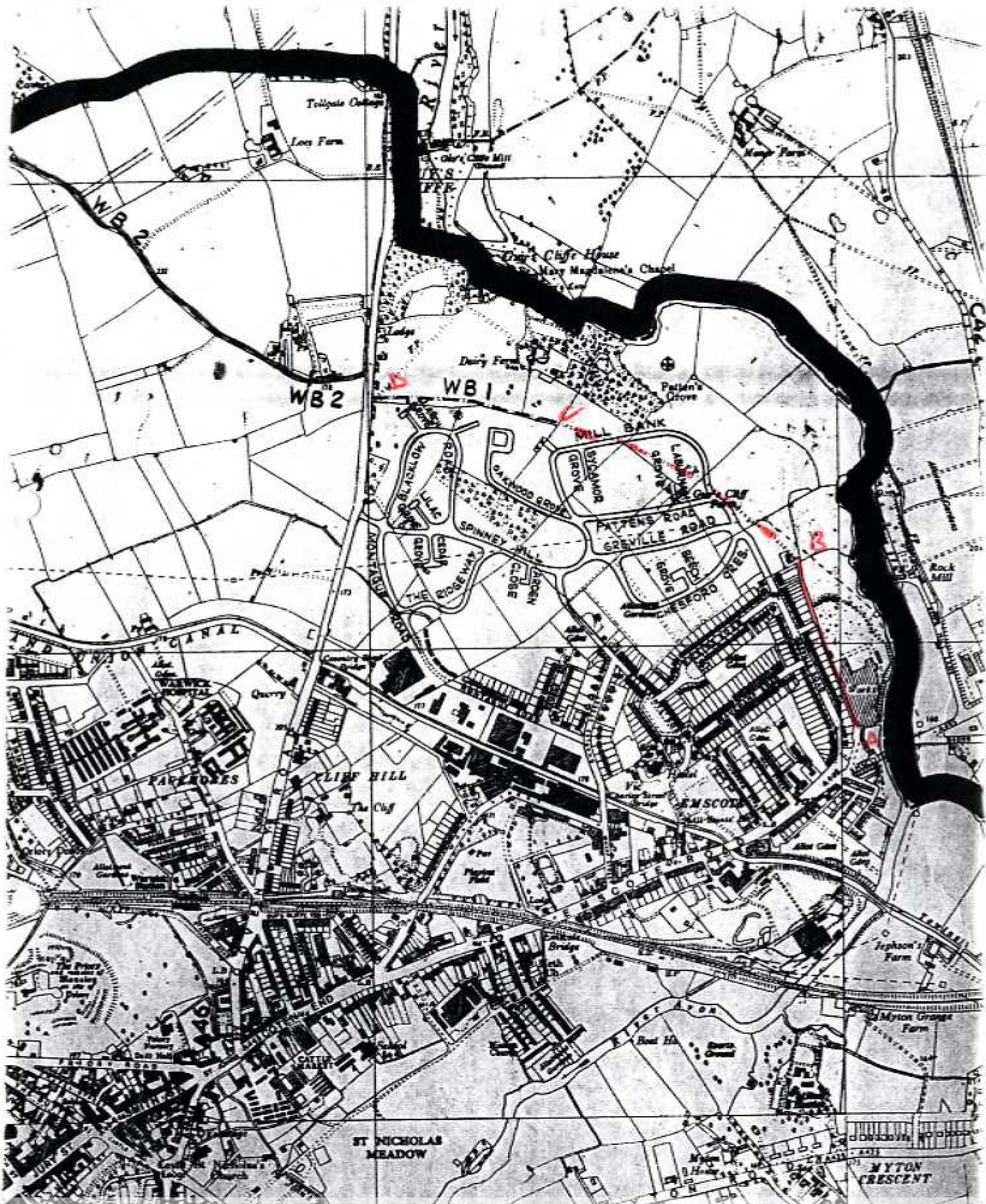
(e) Henry VIII Charity Sale Catalogue 1877 (CR1185/10) shows path through land awarded to the Corporation [part Section B-C]

3) Shown as Route 14 in the booklet "Footpaths in the Vicinity of Leamington" (date not known, but probably 1920's - recently republished)

4) 1932 Rights of Way Act deposit 1936 of plan showing "admitted paths" (CR1618/W6/37) shows the western half of the path [Section C-D + part Section B-C]

5) The Edmundscote Bridge referred to in the Inclosure Award was replaced in 1830 (QS24/28/xviii) and the old road came to be called Waterworks Lane (including part of the present path). Part of the old road was diverted on 18 December 1930 (QS117/2 - no page numbers). The route was described as being part of the highway from the road to Coventry (near Guys Cliffe House) to Emscote Road near the Portobello Bridge.

6) The central section [B-C] (i.e. the Percy Estate development) was the subject of a confirmed Ministry of Transport Order in 1959, although this line (and the original) conflicts with the subsequent, built, housing layout and allotments. This section therefore needs to be resolved !
