Statement of Evidence for path west from Gresham Avenue (between 50 + 52) to Pound Lane, Leamington Spa

- 1) This path was laid out as part of the Gresham Avenue/Taylor Avenue development in the 1930's, as shown on the Building Plans CR2487/699, /735 and /749 held by the Warwickshire County Record Office.
- 2) CR2487/749 is an application, with plans and notices, for the roads and sewers and shows this path coloured, as all the estate roads and other paths. This path is labelled "proposed public footpath 5' 00" wide" and the plan is stamped 'approved' on 13 January 1936.
- 3) Following a dispute about the path, the District Council, as agents for the Highway Authority, accepted (12 June 1997) this path had been adopted as a public highway.
- 4) The route is shown as being publically maintainable on the map of maintainable highways (see attached copy) kept by the District Council as agents.
- 5) This path should, therefore, be added to the Definitive Map as a 'legal event'.

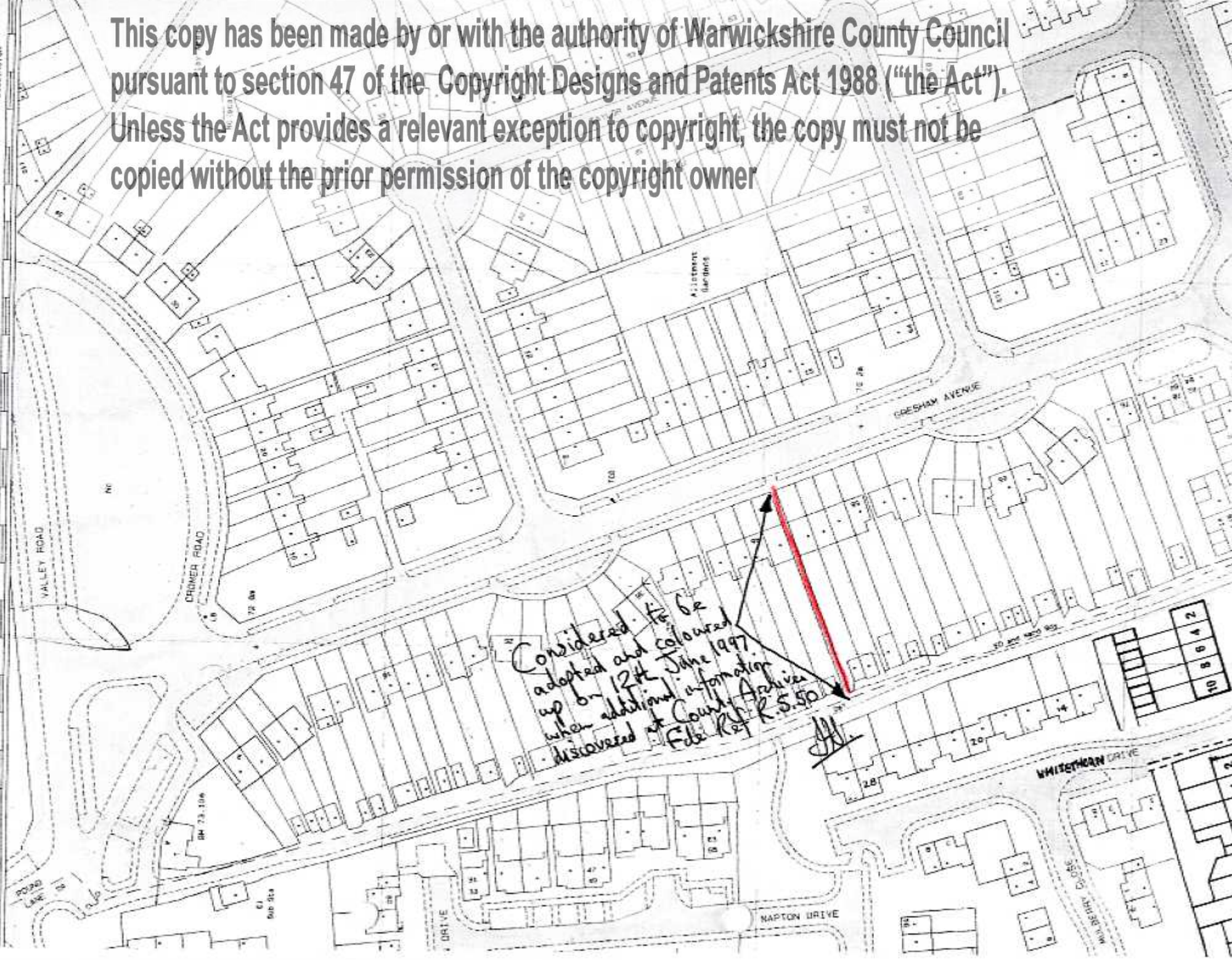
