See attached extract from Ordnance Survey Map (Appendix1)

The route starts from land believed to be common land ("The Green") off Old School Lane, near to the junction with Hampton Road, and passes through a wooden gate (photo 1 Appendix 2) at the side of a gated entrance to a field known as "Charity Field".

The route proceeds between allotments to the east and Charity Field to the west, (photos 2 to 4 Appendix 2) over a wooden stile, (photo 5 Appendix 2) where the allotments terminate, across pastureland close to the boundary with the Charity Field to the west and over another wooden stile (photo7 Appendix 2) to join the footpath on the Henley Road.

The path is approximately 200yards in length, of which some 140 yards is bordered by the allotments and some 60 yards crosses the pastureland.

The path, which appears on OS map 1905 (see Appendix 3) is believed to have originally been a bridle way, used for transporting milk from a dairy farm in Hampton on the Hill to Henley Road and Warwick, foot and bicycle access to the school, post office and store and the allotments, horse riding and walking for leisure purposes.

The use of the path has changed over time, with the closure of the school, post office and store. However, there has been a significant increase in the local population since 1960s and 1970s and the path is now mainly used by allotment holders and for dog walking and leisure purposes.

Users of the path have never been challenged. Residents who have lived in the area for 30 years or more, and in some cases all of their lives, former tenants and a recent owner of the site regard the path to be a public right of way. It is believed the stiles were erected as recently as the year 2000.
