

NOTICE OF MAKING OF AN ORDER

HIGHWAYS ACT 1980

WARWICKSHIRE COUNTY COUNCIL

(PART OF FOOTPATHS R268 AND R268A GRANDBOROUGH) PUBLIC PATH DIVERSION ORDER 2018

The above Order, made on 22 May 2018 under Section 119 of the Highways Act 1980, will **DIVERT** R268 commencing on the drive to Caldecote Farm at Point A (Grid Reference 44718 26485), running generally north northeast for approximately 375 metres to Point B (Grid Reference 44739 26517) **TO A LINE** from Point A running generally east northeast for approximately 236 metres to Point C (Grid Reference 44739 26495), then generally north for approximately 84 metres to Point D (Grid Reference 44736 26503) then approximately 136 metres to Point B (Grid Reference 44739 26517) as shown on the Order Plan. The new route shall have a width of 3 metres between Points A-C-D and 2 metres between Points D-B and also **DIVERT** R268a commencing on the drive to Caldecote Farm at Point E (Grid Reference 44722 26491) running generally east for approximately 274 metres to Point F (Grid Reference 44750 26494) **TO A LINE** from Point C (Grid Reference 44739 26495) running generally east for approximately 105 metres to Point F as shown on the Order Plan. The new route shall have a width of 2 metres.

A copy of the Order and the Order Plan have been placed and may be seen free of charge at the offices of Warwickshire County Council, Shire Hall, Market Square, Warwick CV34 4SA from 8am - 5.30pm on weekdays, (5pm Fridays) and 9am - 4pm Saturdays. Any representations about or objections to the Order may be sent in writing (or email) to the Strategic Director for Communities, P O Box 43, Shire Hall, Warwick CV34 4SX, OR (paths@warwickshire.gov.uk) not later than **22 June 2018**. Please state the grounds on which they are made. Representations or objections may become publicly available and therefore the names and addresses of those persons making representations or objections would also be made publicly available.

If no such representations or objections are duly made, or if any so made are withdrawn, Warwickshire County Council may confirm the Order as unopposed Order. If the Order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the Order.

PUBLIC PATH DIVERSION ORDER

(PART OF FOOTPATHS R268 AND R268A GRANDBOROUGH) PUBLIC PATH DIVERSION ORDER 2018

This Order is made by Warwickshire County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpaths described in paragraph 1 of this Order it is expedient that the line of the paths should be diverted.

Mr and Mrs Angove at Caldecote Farm has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Rugby Borough Council has been consulted as required by section 120(2) of the 1980 Act;

BY THIS ORDER:

1. The public rights of way over the land situate at **Grandborough** and shown by a bold continuous line on the plan numbered P2018/002G contained in this Order ('the Order Plan') and described in Part 1 of the Schedule to this Order shall be stopped up 7 days from the date of confirmation of this Order.
2. There shall at the end of 7 days from the date of confirmation of this Order be public footpaths over the land situate at **Grandborough** described in Part 2 of the Schedule and shown by a bold broken line on the Order Plan.
4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

Between Points A and B on the Order Plan

Footpath R268

Commencing on the drive to Caldecote Farm at Point A (grid reference 44718 26485), running generally north north east for approximately 375 metres to Point B (grid reference 44739 26517) as shown on the Order Plan.

Between Points E and F on the Order Plan

Footpath R268a

Commencing on the drive to Caldecote Farm at Point E (grid reference 44722 26491) running generally east for approximately 274 metres to Point F (grid reference 44750 26494) as shown on the Order Plan.

PART 2
DESCRIPTION OF SITE OF NEW PATH OR WAY
Between Points A-C-D-B on the Order Plan

Footpath R268

From Point A (grid reference 44718 26485), running generally east north east for approximately 236 metres to Point C (grid reference 44739 26495), then generally north for approximately 84 metres to Point D (grid reference 44736 26503) then approximately 136 metres to Point B (grid reference 44739 26517) as shown on the Order Plan.

The new route shall have a width of 3 metres between Points A-C-D and 2 metres between Points D-B.

Between Points C-F on the Order Plan

Footpath R268a

From Point C (grid reference 44739 26495) running generally east for approximately 105 metres to Point F (grid reference 44750 26494) as shown on the Order Plan.

The new route shall have a width of 2 metres.

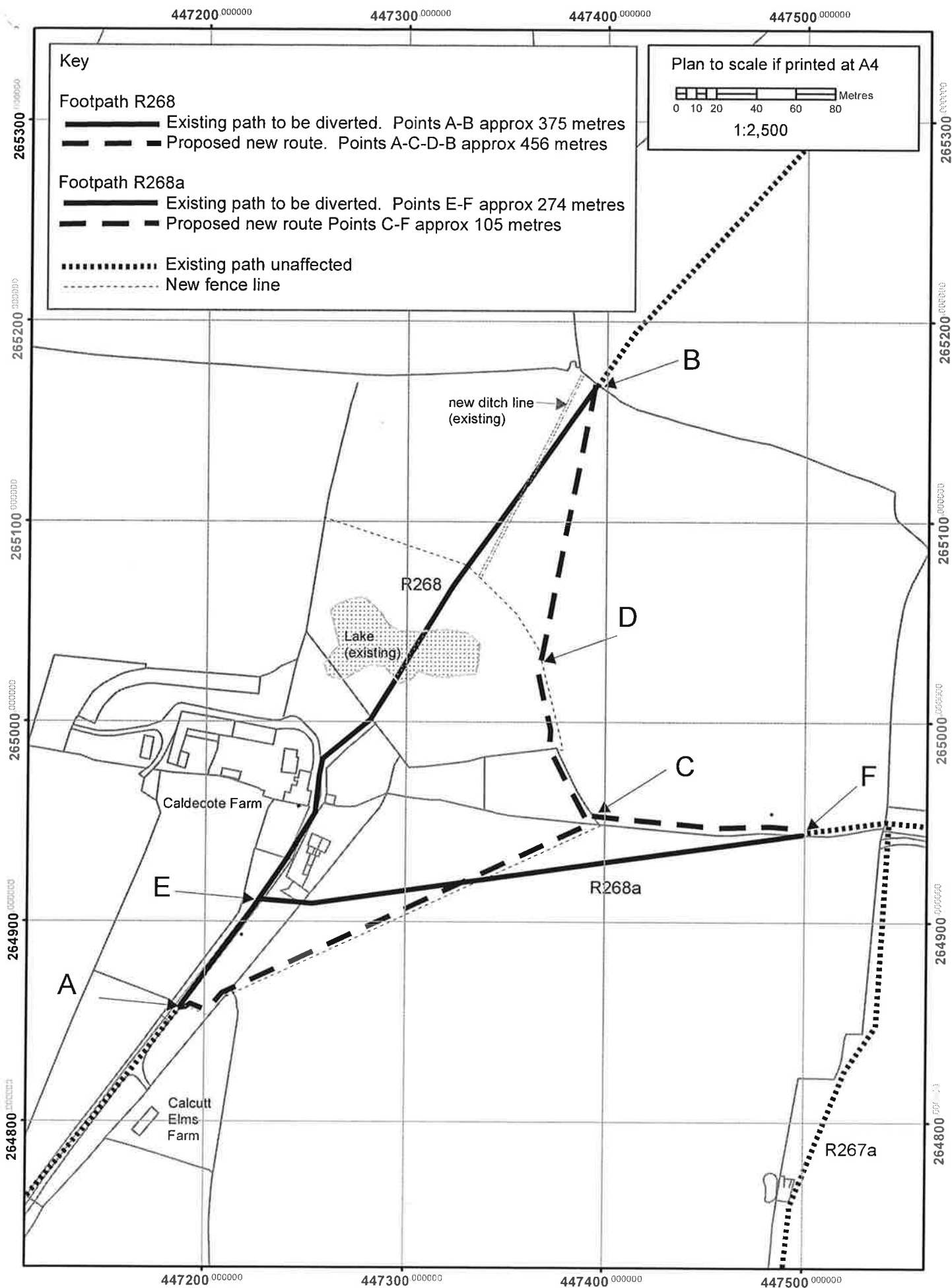
