

NOTICE OF CONFIRMATION OF AN ORDER

HIGHWAYS ACT 1980

WARWICKSHIRE COUNTY COUNCIL

**(PART OF FOOTPATH AL180 ARROW WITH WEETHLEY) PUBLIC PATH
DIVERSION ORDER 2018**

On 6 August 2018 Warwickshire County Council confirmed the above Order made under section 119 of the Highways Act 1980.

The effect of the Order as confirmed is to **DIVERT** from Point A, south of Coldcomfort Farm (Grid Reference 40730 25769) running in a general northerly direction for approximately 175 metres to Point B (Grid Reference 40728 25786) **TO A LINE** from Point A, the path will follow a metalled track north easterly to Point C (Grid Reference 40738 25778) then north westerly to Point B as shown on the Order Plan; a total distance of approximately 254 metres. The new route shall have a width of 5 metres measured from the outer radius of the stone track, widening to 9.2 metres at Point C. The width widens over a 14 metre length between Points Ci-C-Cii as shown on the Order Plan

A Copy of the Order and the Order Plan have been placed and may be seen free of charge at the offices of Warwickshire County Council, Shire Hall, Market Square, Warwick CV34 4SA from 8am - 5.30pm on weekdays, (5pm Fridays) and 9am - 4pm Saturdays. A copy of the Order and Order Plan may be bought there at the price of £5.77. Copies may also be inspected at the offices of the Stratford upon Avon District Council, Elizabeth House, Church Street, Stratford upon Avon CV37 6HX, from 8.45am to 5.15pm Monday to Wednesday, and from 8.45am to 5.00pm Thursday to Friday and online at www.warwickshire.gov.uk/pathorders.

The Order comes into force on 16 August 2018, but if a person aggrieved by the order wants to question its validity, or that of any provision contained in it, on the ground that any requirement of the Act, as amended, or if any regulation made under the Act has not been complied with in relation to the order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 9 August 2018, make an application to the High Court.

PUBLIC PATH DIVERSION ORDER

This Order is made by Warwickshire County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

Ragley Home Farms has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Stratford on Avon District Council has been consulted as required by section 120(2) of the 1980 Act;

BY THIS ORDER:

1. The public right of way over the land situate at **Arrow with Weethley** and shown by a bold continuous line on the plan numbered P2018/001G contained in this Order ('the Order Plan') and described in Part 1 of the Schedule to this Order shall be stopped up 7 days after confirmation of this Order.
2. There shall at the end of 7 days from the date of confirmation of this Order be a public footpath over the land situate at **Arrow with Weethley** described in Part 2 of the Schedule and shown by a bold broken line on the Order Plan.
4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

Between Points A and B on the Order Plan

From Point A (grid reference 40730 25769) running in a general northerly direction for approximately 175 metres to Point B (grid reference 40728 25786) as shown on the Order Plan.

PART 2
DESCRIPTION OF SITE OF NEW PATH OR WAY
Between Points A, C and B on the Order Plan

From Point A (grid reference 40730 25769) the path follows a metalled track north easterly to Point C (grid reference 40738 25778) then north westerly to Point B (grid reference 40728 25786) as shown on the Order Plan. A total distance of approximately 254 metres.

The new route shall have a width of 5 metres measured from the outer radius of the metalled track, widening to 9.2 metres at Point C. The width widens over a 14 metre length between Points Ci-C-Cii as shown on the Order Plan.

PART 3
LIMITATIONS AND CONDITIONS

Two field gates upto a width of 8.2 metres and a 1 metre gap at Point C. The gates may be shut and locked.

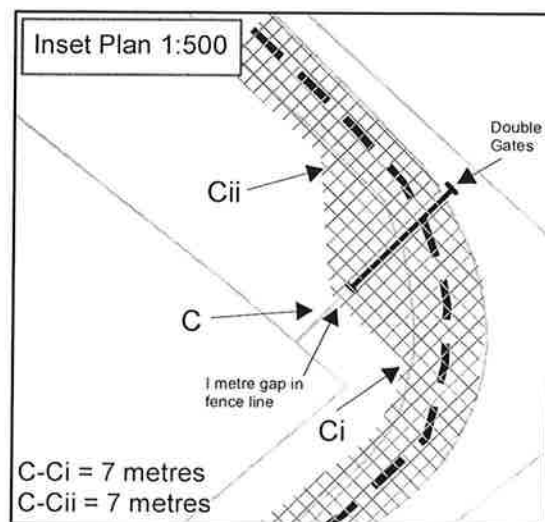
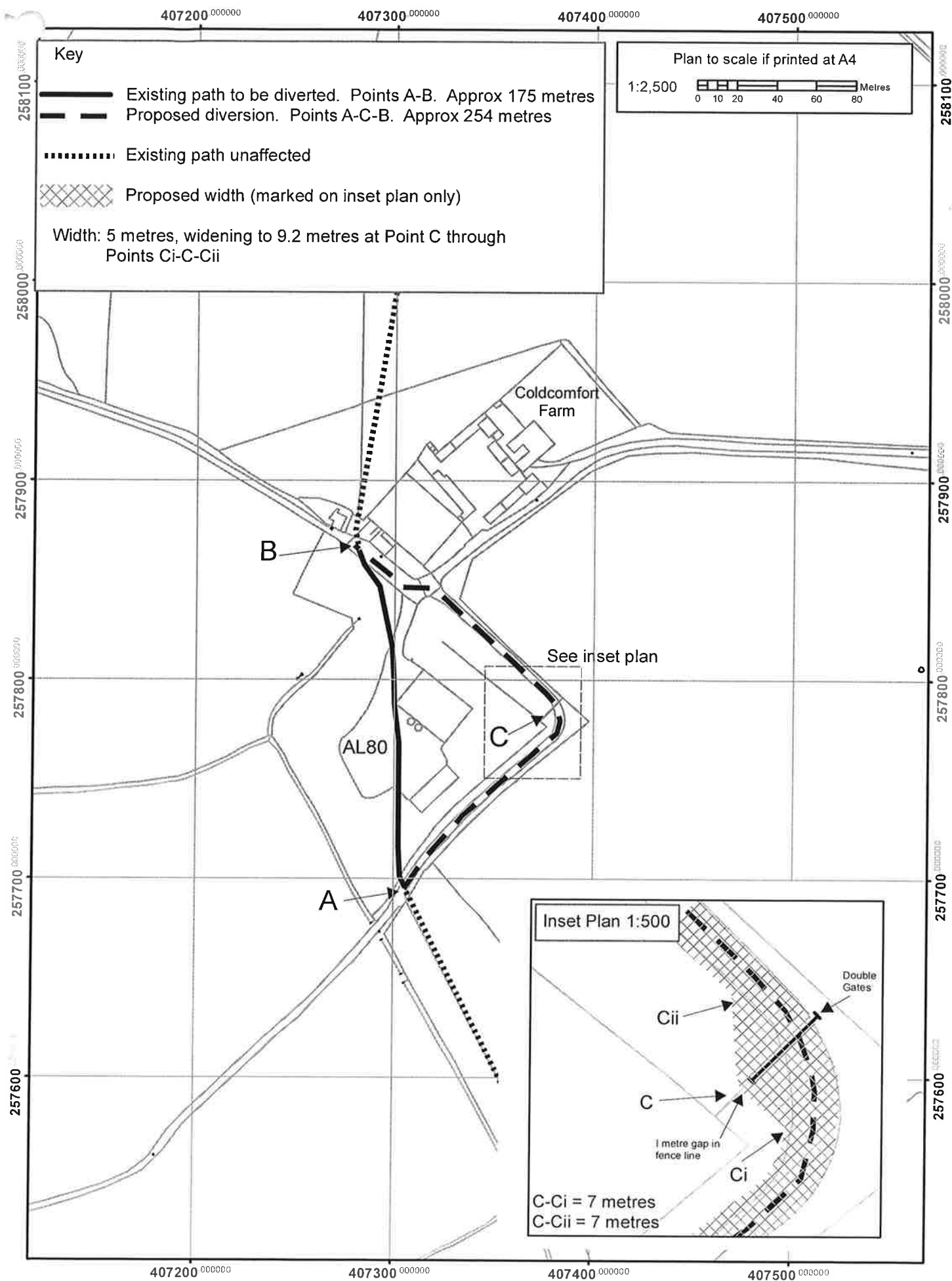
