

# Statement of Evidence for Southam Claim No. 6

- 1) The earliest estate map, dated 1634 (County Record Office ref. Z176/1(u)), does not show the route.
- 2) The estate map of 1734 (Z176/2(u)), however, shows E2998 and SM204 as a continuous road, labelled "To Banbury", over the canal. The reservoir is not shown. The labelling of the placename suggests that the route, as a whole, was public.
- 3) The canal plan of 1777 (Z176/3(u)) includes an inset, but does not show the route, although it appears to be between Upper Banbury Field and Lower Banbury Field on Earl Spencers estate.
- 4) The estate map of 1779 (Z176/4(u)) shows E2998 across the canal with a label "Bridle Road from Wormleighton to Cleydon" added by hand. SM204 has an original label "From Banbury".
- 5) The earliest deposited railway plan is 1836 (QS111/99). This shows E2998 (to the canal) as the 3<sup>rd</sup> entry in Wormleighton, and the Book of Reference lists it as "Road from Wormleighton to Claydon", with no owner. SM204 is listed as the 19<sup>th</sup> entry in Farnborough where it is also shown as going to the canal and is simply referred to as "Road", again with no owner. The description of E2998 clearly shows that the route was continuous, despite the apparent gap at the canal.
- 6) There are two deposited railway plans in 1844. The first (QS111/142) shows SM204 as the 16<sup>th</sup> entry in Farnborough, where it is labelled as "Parish Road". The owner is given as the Surveyor of Highways, with no occupier.
- 7) The second plan (QS111/147) labels SM204 as "Bridle Road" on the map and shows it as being a continuous route to E2998.
- 8) An estate map of 1856 (Z176/5(u)) labels E2998 as a "Bridle Road" "from Cleydon", although the map does not go as far as the canal.
- 9) The last railway plan is from 1863 (QS111/262) and shows SM204 as "Public Bridle Road and occupation road" owned by the Rev. C. Girdlestone and the Surveyor of Highways.
- 10) The route of E2998 and SM204 is shown as being continuous on all Ordnance Survey maps, and this is supported both by being shown as such on some of the above maps and by the written descriptions of the termination points of the route.
