Statement of Evidence for Southam Claim No. 1

- This short length of path forms the western end of the bridleway recorded on the Definitive Map for Northamptonshire and shown on the relevant Ordnance Survey maps as such.
- 2) The claimed route is shown on the 1st Edition of the Ordnance Survey 6 inch to a mile map, 1886, as part of this longer path, although it is not labelled.
- 3) There is no Inclosure Award, or Tithe Apportionment, as the parish has been part of a larger estate, in the ownership of one family, for many centuries.
- 4) The map with the deed of 23rd February 1811 (County Record Office ref. CR1248/29/6) only shows two routes across, or adjoining, the estate, one of which (at least) is a road. The claimed route is not shown.
- 5) The earlier estate map, of 1706 (CR3085), is not available, by instruction of the depositor.
- 6) The route is a clear physical feature on the ground, with waymarks at each end, and has no gate or other barrier at its east end, on the County boundary (see notes of site visit by S. G. Wallsgrove of 9/7/1997).



Waywords at each end: on gate at west end (from byway): - 2 bridleway distes - 1 painting along BR, the other painting east along claim (N.B. quite dearly not miplay S. side of field haundary, where there is another gate.). At east end: CLA footpath diste pointing along bridleway in Northesto. (N.B. Nowbolk Grounds form & i.e. all 3 farms in Newbold Grounds - is side of cambraide access Scheme.)

At east end of claim - wide gap is field boundary hedge - no gate.
