Statement of Evidence

- 1) The claim is for those parts of the route between Warwick Road and Waverley Road, Kenilworth not included on the Definitive Map as K35.
- 2) The first reference to the route is in 1854. The deeds for the former tannery site (now the site of Talisman Square), dating from 1690 to 1880 (County Record Office ref. MI 179) include an application dated 27 June 1854 to close the public footpath (actually part of a longer path) from Station Road south to "another path" (the claimed path).
- 3) The Quarter Sessions Order of 1854 (County Record Office ref. QS47/79) shows, on the plan, the path to be closed as terminating at its south end on "Shut Lane", which is shown as continuing east, as a path, which is labelled as "to the railway station".
- 4) The west end of the path is shown on the Board of Health Map of c.1877.
- 5) The whole path is shown on all large scale Ordnance Survey maps.
- 6) The east end of the path (shown as K35) was diverted in 1909 (County Record Office ref. QS47/230A) when the gap between the two numbered parts was shown, the old route being described as being 4ft wide with the new (diverted) route being 6ft wide.
- 7) In 1964 the planning application for the youth centre and nursery school (Plan No. KUDC 5436 held by Warwick District Council) referred to the need to divert the path.
- 8) The diverted route is shown, crossing Bertie Road, as K35 on the Definitive Map.
- 9) The whole route is shown on the list of streets map, kept by the District Council as agents for the Highway Authority, as maintainable at public expense.
- 10) The whole route has a tarmac surface, is generally well maintained, and has street lights. It is heavily used by the public.


