Statement of Evidence

- 1) This route is an ancient path from the east side of Warwick Road eastwards through the fields to Windy Arbour.
- 2) The 1841 Warwick and Leamington Branch Railway deposited plan (County Record Office ref. QS111/129/1+4) shows, and labels, item 53 as "foot road to Stoneleigh" in a pasture.
- 3) The Tithe Apportionment Map of 1849 (County Record Office ref. CR569/139) shows and labels the section to the east of the claimed part as "footpath".
- 4) The route is shown on all large scale Ordnance Survey maps.
- 5) The area to the east of the railway was developed in the 1960's and the remaining section of the path, between Farmer Ward Road and the east side of the Railway (the boundary of the excluded area) was shown on the original Definitive Map as K24.
- 6) Path K24 was closed in 1964, presumably when a larger area (now grassed and with the footpath ramp along its north edge) was adopted as highway.
- 7) The bridge over the railway from Clarendon Road, with Farmer Ward Road, the grassed area, and the ramp, are shown on the map of the list of streets kept by the District Council as agents for the Highway Authority as being maintainable at public expense, a date of 18/6/91 being written on the map. This is presumably the date when the footbridge itself was adopted as highway.
