Statement of Evidence

- 1) The original path went from the west end of Albion Street, Kenilworth generally west-south-west across the (later) Priory Road, as "The Blundells", then generally south-west across the (later) Southbank Road to the (later) station Road at the back of the Kings Arms and Castle then south to 'Shut Lane'.
- 2) The central section (including the later Southbank Road) is shown on an estate map of 1844 as crossing diagonally over two fields. This plan is with deeds of 1760 - 1872 for various properties in Kenilworth (Coventry Record Office under TC/1/L/133)
- 3) On 27<sup>th</sup> June 1854 an application was made to close the public path south from Station Road to "another path". (In deeds of the former tannery site (now Talisman Square) 1690-1880: County Record Office ref. MI 179)
- 4) The Quarter Sessions Order of 1854 (County Record Office ref. QS47/79) closed this path, from Station Road south to the end of Shut Lane, the plan showing this lane as continuing as a path)
- 5) The section from Station Road north-east to a point to the east of the then proposed Southbank Road was diverted on 1<sup>st</sup> July 1873 to create the west end of the passage finishing on the east side of Southbank Road. The rest of the path was diverted onto the then proposed road. (County Record Office ref. QS47/121)
- 6) This diverted route, with The Blundells, is shown on the Board of Health drainage map of c.1877
- 7) The route is shown on all large scale Ordnance Survey maps
- 8) The route from Albion Street to half way between Priory Road and Southbank Road is shown as being maintainable at public expense on the map kept by the District Council as agents for the Highway Authority, with the remaining length being labelled "public right of way"
- 9) The route has a tarmac surface, with "no cycling" notices, and is well used by the public.




