Statement of Evidence

- 1) This path was created by the Kenilworth Inclosure Award 1756 (County Record Office ref. QS75/63), the second common footway being described as “one other foot way from Cripplegate Lane [now Clinton Lane] over one of the allotments hereinbefore allotted to James Roe in Priors Field and over one of the allotments hereinbefore allotted to Thomas Lucas thence to the top of Bull Hill [now Castle Hill] of the breadth of four feet”. (N.B. The allotment to Thomas Lucas has Malthouse Lane on the east and Castle Hill on the south.)
- 2) The path is shown on an estate map dated 12 September 1792 as going along the south edge of a field (parcel 5) now the site of Clinton Avenue and Denton Close. (Birmingham Reference Library ref. E12 = deed of 1746 from Lord Hyde to James Roe)
- 3) Part of the path is shown on the Board of Health drainage map of c.1877 on which it is coloured and labelled “footway to High Street”
- 4) The route is shown on all large scale Ordnance Survey maps
- 5) The planning applications for Denton Close (developed in two parts) show/label the path on the location/layout plans but outside the development sites (Held by Warwick District Council as KUDC 4251 and 4489 for the northern half and 5509 and 5753 for the southern half)
- 6) The route (except for Clinton Avenue) is shown as being maintainable at public expense on the map kept by the District Council as agents for the Highway Authority. (Clinton Avenue is presumably omitted since this is a private vehicular route, and should only be maintainable as a footpath.)
- 7) The route has a tarmac surface, street lights, and ‘no cycling’ notices, and is well used by the public.


