Statement of Evidence

- 1) The bridleway K10 starts at the boundary of the former excluded area, with the continuation back to Castle Green being a single track with no alternative route.
- 2) The estate map of 1692 (County Record Office ref. CR143/1) shows the whole track, from Castle Green.
- 3) The whole route of the track is shown on the first edition of the Ordnance Survey one inch map of 1834
- 4) The Board of Health drainage map of c.1877 shows the route coloured, but not labelled.
- 5) The whole route is shown on all large scale Ordnance Survey maps
- 6) The route has a bridleway signpost at Castle Green and is well used by the public as the only access into the path network.
