I hereby apply for an Order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the County of Warwick by **Adding** the following route as a -

Statement of Evidence

- 1) The western part of this path, namely that part in Barford parish, was created by the Barford Inclosure Award of 1760 (County Record Office QS9/13), the path being the 4th awarded "common footway". This is described as being 4 feet wide:-
"leading out of the said footway from Barford towards Plaistoes [i.e. the 1st awarded path, being identifiable with the western part of W103 since it started from the end of Church Lane] at the north-east corner of the Glebe Leasow over the first allotment to Richard Wright and John Hobbins on the south side of Short Knit Heath to the first allotment to John Mills and over the last mentioned allotment to John Mills to a certain stile at the east end of Further Rudall leading into certain grounds in the parish of Tachbrooke in the occupation of John Russell".
- 2) The allotments to Richard Wright, John Hobbins and John Mills are shown on the related map (CR469) while the reference to a stile on the parish boundary with Tachbrooke shows that it was an existing path continuing through that parish. This map, however, does not show the route of any of the awarded paths.
- 3) An estate map of 1810, of the Glebe Land and estates of Rev. and C. Mills (County Record Office P30) covers most of the area between Hareway Lane and the parish boundary, and shows the route of the path, which is labelled "from Barford" and "to Tachbrook". The western end is along the edge of a field called "Short Heath" (presumably from "Short Knit Heath" in the Inclosure Award) with the eastern end being by a field called "Far Rydel" (presumably from "Further Rydall" in the Inclosure Award). It is considered that these details confirm that the claimed path is that in the Inclosure Award.
- 4) The route shown on this estate map is the same as that shown on all later, large scale, Ordnance Survey maps (particularly the first edition six inch map, which also shows the east end of the path, up to the Banbury Road), despite some changes to field boundaries which occurred after 1810.
- 5) The western end of this claimed path, namely the field not shown on the 1810 map, formed part of Hareway Farm which, in 1899 (CR737/78) was acquired by the Smith-Ryland family. The deeds for the purchase of various farms were deposited in the County Record Office and, in the case of this farm, a "Requisition on title and replies" was completed. Question 11 asked about rights of way with the answer saying 'there is a public footpath to Tachbrook which is shown on the accompanying plan'. A copy of this plan is enclosed herewith where it can be seen that the east end of this path is labelled "Right of Road to Mr Cannings Homestead and Public Footway to Tachbrook etc.".
- 6) Mr Canning held Debden Farm which, under the 1910 Finance Act Field Book of 1913 (Public Record Office Class IR 58) (copy enclosed herewith) included a restriction of "one footpath to Tachbrook", which was claimed as affecting the market value and for which an allowance of £25 was made under the heading of "Public rights of Way or User".
- 7) The adjoining farm to the east is Red House Farm in Bishops Tachbrook, which occupies the whole area from the parish boundary to the Banbury Road. The Return made under the Finance Act 1910 (Form 37 - land) is held by the County Record Office (CR1974) and this, also, records an allowance for "Public Rights of Way or User", this time for £30. (Copy enclosed herewith). The Finance Act Map shows that there was only one path across the farm, being the continuation of the Barford path to the Banbury Road opposite the road to Bishops Tachbrook village.
- 8) This documentary and cartographic evidence is supported by statements made by 7 elderly

residents which were collected in 1977, when the Definitive Map was under review. These are enclosed as RA refs. I43, I48, I49, I50, I52, I54 and I98.

9) When the Side Roads Order for the M40 Motorway was being considered, this path was drawn to the attention of the then Department of Transport, and the Inspectorate, but they would not accept its existence unless it was on the Definitive Map. They did, however, move the proposed farm access bridge over the motorway so that, as far as possible, it coincided with the line of the claimed path.
