Statement of Evidence

)

- 1) the earliest evidence for this road is the 1788 estate map of the Manor of Budbrooke (County Record Office CR 895/101). This shows the route as a road in the same way as all other roads in the parish, with a central, coloured, track turning from one road into the next, with the road to Henley at the north end and the road to Norton Lindsey at the south end. No barriers are shown.
- 2) The two fields on the east side of the route belonged to the Trustees of King Henry VIII Charity. The estate map of 1807 (CR1618/WA6/178) shows it in exactly the same way as the roads at each end, namely that to Henley in Arden and that to Claverdon, in that it is not only not separated from these roads in any way but shows that the hedges were on the field side of the ditches.
- 3) The Grove Park Estate Map of 1828 (which shows the whole parish) (CR895/105) also shows the route as an integral part of the road network, linking the Henley and Norton roads. Again, no barriers are shown.
- 4) The first edition of the Ordnance Survey one inch map of 1831 also shows the route as an integral part of the road network.
- 5) The staus of the route is confirmed by the Budbrooke Tithe Apprtionment of 1842 (CR569/48) which again shows the route coloured yellow as an integral part of the road network, with no barriers across it. The Book of Reference lists these "Public Roads and Wastes", which are recorded as covering 33 acres 3 perches, as being not subject to tithes.
- 6) The status, and ownership, of the road are further confirmed by the deposited plans of the Rugby, Warwick and Worcester Railway 1845 (QS111/175) which identifies the route as item 16. The Book of Reference lists this as "Highway", in the ownership of the Surveyor of Highways, in the same way as the road to Norton Lindsey (entry 15) and the road to Henley (entries 21 and 27).
- 7) The land to the east of the two fields of the Henry VIII Charity belonged to Weales Exhibition Charity and the estate map of 1868 (CR170/44) shows the southern end of this route, even though it did not adjoin the site. Presumably, this was because it was considered to be an important identifying feature.
- 8) This Charity land was sold in 1878 (when it was referred to as a sale by the Governors of Kings Schools, Warwick) and the plan (CR237/541/5) again labels the Henry VIII Charity land and shows the the southern end of the route.
- 9) The road is shown on all subsequent Ordnance Survey maps, of all scales.
- 10) The route is shown on the maps prepared under the 1910 Finance Act as being excluded from the adjoining hereditaments, thereby strongly supporting the case that it is a public road.
- 11) There has been no closure or extinguishment of the road either in Quarter Sessions or advertised in the London Gazette.
