Statement of Evidence

1) The Tithe Apportionment of 1843 (County Record Office CR328/30) shows a road, coloured in the same way as all other roads on the map and of a similar width to those roads, going south from the line of the present Old Warwick Road to the edge of the plot with a canal building on it. It is included in the Book of Reference as part of the waste land of the parish, and as not titheable. This suggests, quite strongly, that it was a public highway.

2) The Harborough Banks Inclosure Award of 1863 (QS75/69) enclosed this waste land and laid out various public roads and public paths. The first public path was coincident with the accommodation road now known as Bromehall Lane and the second was described as being 4 feet wide and

“commencing at the Northwest corner of the Allotment numbered 11 and extending thence along the North side of the said Allotment to and terminating at a stile at the Northwest corner of the said Allotment numbered 11”.

The map shows this to be the western part of the claimed route.

3) The whole path is shown on all the large scale Ordnance Survey maps since that time, namely from the first edition of the 6 inch and 1/2500 scale maps to the present day.

4) This path, as recorded in our 1977 claim, had a notice at its Bromehall Lane end saying “path to canal”, a feature accepted in a letter by the then manager of the National Trust (who then managed the restored canal), as submitted herewith (RA ref. I64).

5) This path goes east from Bromehall Lane to the canal and has the British Waterways yard buildings on the south and the wooded carpark and picnic site of the District Council on the north. The physical features of the path, namely its well worn surface and lack of obstructing overgrowth, show that it is well used.

6) This documentary evidence is also supported by four signed statements from local residents, all collected in 1977 (see RA refs. I64, I87, I88, and I93).
