**THE WARWICKSHIRE COUNTY COUNCIL (SALTISFORD/ NORTHGATE/NORTHGATE STREET, WARWICK)
(PROHIBITION OF RIGHT TURN) ORDER 2018**

THE WARWICKSHIRE COUNTY COUNCIL (NORTHGATE STREET/BARRACK STREET, WARWICK) (RIGHT TURN ONLY) ORDER 2018

Warwickshire County Council propose to make the above Orders under the Road Traffic Regulation Act 1984 the effect of which will be:

1. to install a raised table feature as described in Schedule 1
2. to install other traffic calming measures as described in Schedule 2 below.
3. the prohibition of a right turn as described in Schedule 3.
4. a right turn only as described in Schedule 4

A copy of the plan showing the proposed locations of the traffic calming measures and a statement of the Council's reasons for proposing to install them may be inspected at the Main Reception, Shire Hall, Market Place, Warwick; at the Warwick District Council, Riverside House, Milverton Hill, Leamington Spa, CV32 5HZ; and at the Public Library, Shire Hall, Warwick during usual opening hours.

Any objections to the proposals, which must be in writing and specify the grounds on which they are made, should be addressed to Graham Stanley, Communities Directorate, PO Box 43, Shire Hall, Warwick, CV34 4SX. (Objections, and the name of the objector, will normally be treated as public information and may be published.) Information will be kept for a period of time. Objections must be sent so as to be received by 23 August 2018.

SCHEDULE 1

Proposed Raised Table (Road Hump) Saltisford/Northgate/Northgate Street/Barrack Street – Warwick Town Centre **Proposed 75mm Raised Table (Road Hump), with 2.0 metres On/Off Ramps**

- (i) 75mm raised road hump, 8.0 metres wide on Saltisford/Northgate from its junction with Joyce Pool to its junction with Cape Road for approximately 53 metres.

- (ii) 75mm raised road hump, of varying width between 4.0metres and 6.8 metres wide on Northgate Street from its junction with Saltisford/Northgate for approximately 51 metres in a southerly direction.
- (iii) 75mm raised road hump, 3.1 metres wide on Barrack Street from its junction with Northgate Street for approximately 23 metres in a south-westerly direction.

SCHEDULE 2

Proposed Pedestrian Refuge Crossing Points Saltisford/ Northgate Street

- (i) Two Pedestrian Refuges located on Saltisford/ Northgate Street, 1.8m wide, located near the junction of Saltisford/Joyce Pool Road and approximately 13 metres west of Cape Road.

SCHEDULE 3

Proposed Prohibition of Right Turn Saltisford/Northgate

- (i) Eastbound vehicles on the A425 Saltisford/Northgate, Right turn prohibited into Northgate Street, Warwick.

SCHEDULE 4

Proposed Right Turn Only from Barrack Street into Northgate Street

- (i) Right turn only for vehicles travelling on Barrack Street into Northgate Street, Warwick.
