Street entertainment:

Busking creates a vibrant and exciting atmosphere in Warwick District. The Council wish to ensure that busking continues to contribute to the thriving district. Street Entertainment and busking is not administered or regulated by Warwick District Council as it is not a licensable activity.

We wish to ensure that everyone benefits from such entertainment whilst minimising noise disturbance and any intrusive behaviour that could affect neighbouring businesses, residents, visitors or surrounding environment. The Council is in the process of considering its approach to Busking and Street Entertainment. We are reviewing a number of options including the approach used by City of York Council.

Leisure Development Programme:

Warwick District Council is developing ambitious plans to invest in and secure the future of the <u>district's leisure facilities</u> for the next 20 to 30 years. It is proposed that over the next eighteen months £12 million will be invested in Newbold Comyn and St Nicholas Park leisure centres. Councillors will make a final decision on the proposals next summer. The planned refurbishment and improvement programme will include:

- the creation of brand new health and fitness
- new changing facilities
- upgraded reception areas in both centres
- the construction of a new four-court sports hall at Newbold Comyn

Green Space Development Team:

The Council are keen on proving the local environment by making them safer, cleaner and greener.

- Twycross Walk 6.61 hectares, Neighbourhood
- Canalside 0.6 hectares, Neighbourhood
- Hickmans Green Local
- The Marish Local
- Hatton Park 0.31 hectares, Neighbourhood

The future plans are as follows:

- 2016 Priory Pools improvement project
- 2016 Millbank Gyme Equipment following improvement project 3 years ago.
- 2017 Saltisford Common Improvement project
- Othello Avenue tbc
- Ongoing St Nicholas Park ongoing improvements when funding is available.
- Parks audit for all sites.
- Annual play area inspections for all sites.
- Management/ development plans to be drawn up over the next 2 years.

Police priorities:

The agreed policing priorities for the period March 2016 until June 2016 are as follows:

- Carry out x 15 patrols along canal towpaths in Warwick
- Carry out x 20 ASB/ Reassurance patrols at St Nicholas Park, Kingfisher pools. Myton Fields
- Carry out x15 high visibility patrols to deter the use of ASB due to use of vehicles in Parks and Open Spaces
- Carry out x15 high visibility patrols to deter criminal damage and shed break-ins
