- ATH14, Atherstone Football ground, Sheepy Rd, Atherstone
 2.2ha 46 units
- Britannia Mill redevelopment site, Coleshill Rd, Atherstone 0.4ha 54 units (from submitted application).

Employment Sites

- Land south of Rowlands Way east of Aldi (Aldi expansion Land), Atherstone - 6.6ha
- Land north of Whittington Lane, Aldi expansion Land, Atherstone - 1.5ha





(Ansley Common included in Area Forum East as it is a linked settlement with Hartshill in the Local Plan).

Housing Sites

- HAR 3, Land between Church Rd and Nuneaton Rd, Hartshill.
 30.4ha 400 units
- ANSCOMM 1, Land off Coleshill Rd, Ansley Common. 1.8 ha -38 units (application pending for 76 units)
- Land at Ansley Common, north of Coleshill Road. 19.7 ha -355 units (subject to feasibility study),
- Land at Ansley Common, south of Coleshill Road. -12.8ha -230 units.








Hartshill - East
