1. Welcome, Introductions and Apologies Cllr Longden welcomed everyone to the meeting.

2. Bermuda Bridge 'bridge to nowhere' - follow up meeting

Cllr Longden introduced the main agenda item by referring to the presentation given at the last meeting in July which proposed the Bermuda Connectivity Project (BCP).

Cllr Longden asked for feedback and comments on the proposal by taking the meeting through the questions and answers paper attached to the agenda.

The majority of residents present made it clear they did not want the bridge opened to traffic by expressing their objection to the entire scheme. They focused their discontentment on: a lack of options for alternative transport routes through west Nuneaton; the negative environmental impact on Bermuda; the lack of design detail and traffic modelling; the project not addressing adopted guidelines and protocols for transport infrastructure schemes.

It was agreed a full list of questions and responses (where possible) would be collated and attached to the minutes to share with the Forum via email. All residents were encouraged to fill in their email addresses on the attendance sheet.

A petition against the Bermuda connectivity project signed by around 600 residents was handed in and accepted by the Chair.
